The Agreement between Good Book Publishing and the Author

The above named author, hereafter referred to as "the Author," agrees to the following, in order that Good Book Publishing may produce a Lasting Legacy Book™ for the Author. Good Book Publishing is a subsidiary of Good Catch Publishing.

The Author will submit a completed *Lasting Legacy Questionnaire* producing the general storyline of the book. Good Book Publishing will conduct seven two-hour interviews with the Author and will write the story as it is presented in said interviews. The Author will schedule and agree to keep all interview appointments with the writer. Should the Author miss an interview without providing 24 hours' notice, the Author will be charged a \$25.00 missed interview fee.

Good Book Publishing will produce a trade paperback book of seven chapters. Each chapter will contain up to 7,000 words. The Author will have an opportunity to review and revise each chapter as it is written. The Author may revise each chapter up to three times. If the Author needs more than three revisions on a chapter, the Author may request additional revisions for \$50.00 per revision. The finished book will contain between 160 and 225 pages. Additional chapters up to 7,000 words in length can be written for \$500 per chapter. The book's trimmed size will be approximately 5 ¼ by 8 ¼ inches. The four-color, high gloss cover will be created with stock art from the Good Book Publishing website and will be customized with the Author's picture, name and title. If the Author so chooses, a completely custom cover can be created by a Good Book Publishing graphic artist for an additional fee of \$500.00.

Good Book Publishing is not responsible for the accuracy of the story. The book will be reviewed by The Author for accuracy. Good Book Publishing will not be held liable for any inaccuracies or less than true statements.

Good Book Publishing reserves the right to refuse to publish any element of a story Good Book Publishing deems unacceptable.

Upon the Author's approval of the manuscript, Good Book Publishing will print 25 copies of the book and ship them to the Author.

Good Book Publishing will archive the book for future printing. The Author will retain the right to purchase the book from Good Book Publishing at prices quoted at that future time. Good Book Publishing will retain exclusive rights to print the book. The book may not be reproduced in any form including electronic or audio without the expressed written permission of Good Book Publishing.

The price for the book, not including additional fees incurred, such as a custom cover or missed interview fees, is \$4,995.00.

To initiate the writing of the book, the Author must submit a credit card to Good Book Publishing. A down payment of \$2,000.00 will be debited from the credit card at the time of the contract submission. \$1,500.00 of the \$2000.00 down payment will be refundable up to the time of the approval of the first chapter. After the Author approves the first chapter, the \$2,000.00 down payment will become non refundable. Three more payments (\$1,000.00, \$1,000.0 and \$995.00) will be deducted on the first of each of the three months following receipt of this contract for a total of \$4,995.00. (Additional fees as stated in this contract will be applied to the final payment.)

If for any reason Good Book Publishing chooses to terminate work on the book, all funds will be refunded to the Author and the Author will have no further recourse. If the Author chooses to end the writing process after the first chapter has been approved but before the entire book has been written, the Author will not receive a refund of any of the funds Good Book Publishing has collected prior to the date written notice of cancellation is received at Good Book Publishing headquarters. If the Author chooses to terminate the writing process after the first chapter has been approved, the Author must notify Good Book Publishing in writing. Upon receiving written notice of cancelation, Good Book Publishing will refund any additional funds received from the Author after the date the written notice of cancelation was received from the Author. (The official cancelation date will be either the date the e-mail was received or the post date of a letter sent via USPS Mail.)

Upon completion of the writing and prior to printing, the Author will receive electronic proofs of the book, which the Author must approve before printing.

Upon completion and approval of the book, Good Book Publishing will ship 25 books to the Author.

Copyrights

Good Book Publishing will retain all copyrights to the book. Permission must be secured from Good Book Publishing to reproduce the book in any format, including but not limited to electronic or audio.
